PROFESSIONAL VOTING MEMBERS

Membership in this category shall be open to any individual licensed as or acting as a "mortgage loan originator." Members in this category have a vote in the affairs of the Association. Mortgage loan originator means a person who is in the profession of making or negotiating, directly with the consumer, the origination of loans secured by real property.

PROFESSIONAL NON-VOTING MEMBERS

Membership in this category shall be open to any individual licensed or registered as a mortgage loan originator or employed by a retail mortgage origination company. A retail mortgage origination company is defined as any company that is in the profession of making or negotiating, directly with the consumer, the origination of loans secured by real property. Non-voting members may serve on committees but shall not have a vote in the affairs of the Association unless they have been elected to serve on the Board of Directors.

MEMBERSHIP IS FOR INDIVIDUALS

Please note that all memberships in GAMP are for individuals, not companies. In order to receive GAMP emails, each person must be a member.

CODE OF ETHICS

- **Honesty and Integrity.** GAMP Members shall conduct business in a manner reflecting honesty, honor, and integrity.
- **Professional Conduct.** GAMP Members shall conduct their business activities in a professional manner. Members shall not pressure any provider of services, goods or facilities to circumvent industry professional standards. Equally, Members shall not respond to any such pressure placed upon them.
- **Honesty in Advertising.** GAMP Members shall provide accurate information in all advertisements and solicitations.
- **Confidentiality.** GAMP Members shall not disclose unauthorized confidential information.
- **Compliance with Law.** GAMP Members shall conduct business in compliance with all applicable laws and regulations.
- **Disclosure of Financial Interests.** GAMP Members shall disclose any equity or financial interest they may have in the collateral being offered to secure a loan.

PROFESSIONAL STANDARDS AND BEST LENDING PRACTICES

GAMP Members must promise to their customers that they will:

- Offer rates and fees that are not discriminatory based on race, color, religion, national origin, gender, marital status, sexual preference, or disability;
- Abide by all federal and state regulations pertaining to the mortgage lending industry such as ECOA, RESPA, TILA, FCRA, and Federal Lending Statutes;
- Disclose accurate information in all solicitations and advertising;
- Discuss and explain financing program options;
- Inform the customer of lock-in options, and provide the customer with a written document which states the customer's loan terms and rates, whether floating or locked;
- Explain all documents of the loan application;
- Explain all costs associated with the loan transaction;
- Explain the disbursement of fees collected at application;
- Explain the loan process, from application to closing;
- Charge only those fees disclosed or re-disclosed on the customer's Good Faith Estimate;
- Communicate with the customer throughout the loan process in a timely manner;
- Provide customer with a written agreement, which explains the nature of our relationship with the customer and how the member is compensated in the transaction.
- Not engage in or respond to any pressure or influence from any party that seeks to circumvent professional industry standards, guidelines, rules or regulations in a mortgage transaction. The member has the right to select all providers of services so long as it is within the scope of industry professional ethics and standards.
